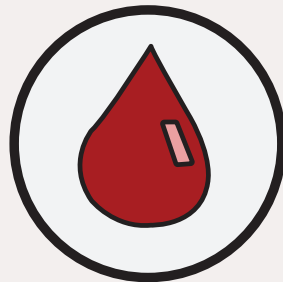

Early Intervention

About

- Home and community services to support learning.

Requirements

- Children ages 0-3 with blood lead level above 5 µg/dL.

ACHD Safe and Healthy Homes

About

- Free home visit to look for health and safety hazards.
- Takes 2-3 hours.

- Pregnant woman or person under 22 is often in home.

- Available to renters and homeowners in Allegheny, Beaver, Washington, and Westmoreland Counties.

ACHD Home Lead Investigations

About

- Home lead risk assessment (2-4 hours, depends on size of home). Test paint, take dust, water, and soil samples.
- Education on lead exposure and prevention.

Requirements

- Children under 6 with confirmed blood lead levels 5µg/dl and above.
- Live in Allegheny County.

ACED Lead Safe Homes

About

- FREE repairs to make homes safe from lead-based paint.

Requirements

- Home is in Allegheny County; built before 1978.

- Open to all tenant housing or owner-occupied housing where a pregnant woman or child under 6 lives or regularly visits.

Water Filters

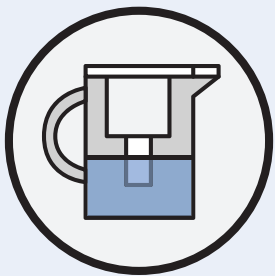
About

NSF certified water pitchers and filters remove lead.

To purchase a filter

- Check your local hardware store or big box retailer.
- Filter pitchers cost around \$25.
- Make sure it is NSF-certified to remove lead.
- Filter cartridges need to be replaced according to manufacturer recommendation.

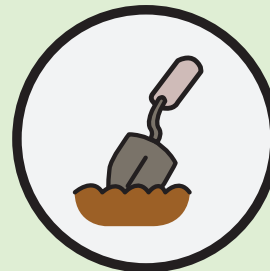

• Homeowner in the City of Pittsburgh.

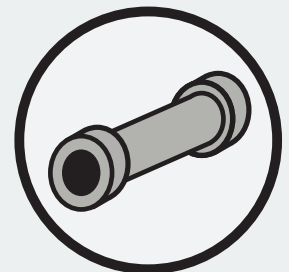

Lead service line replacement with PWSA

About

Owners of properties with a lead public service line (from the water main to the curb) can coordinate replacement with PWSA. If your private line (from curb to home) is also lead, you may be eligible to have your line replaced at no cost. Low-interest loans are also available.

Requirements

- PWSA drinking water customer.
- Homeowner.
- At least one portion of service line is lead (private and/or public).
